## FOUNDATION ANNOUNCEMENTS

- The new Secretary of the Permanent Mission of the Holy See to the UN, Mgr. Mauro Cionini, took office on February 6, 2017. He has a multilateral background, having been Secretary at the Permanent Mission of the Holy See in New York from 2010 to 2013.
- During the 36th Session of the Human Rights Council (September 2017), the Foundation will organize, together with the Permanent Mission of the Holy See, a Side Event on the Right to Water. Invitation will follow.

## ACTIVITIES

### Conferences

Since the beginning of the year, the Foundation participated in the organization of several high-level seminars to discuss specific topics of international relevance. In recent months, the President of the Foundation, H.E. Archbishop Ivan Jurkovič, participated in and intervened on the following:

- 105<sup>th</sup> Session of the International Organization for Migration (IOM) Council, Geneva, December 2016;
- 140<sup>th</sup> meeting of the Executive Board of the World Health Organization, Geneva, January 2017;
- 2<sup>nd</sup> Dialogue on Faith, Peacebuilding & Development, Geneva, February 2017;
- First Thematic Consultation on the Global Compact for safe, orderly and regular migration, Geneva, May 2017;



In March 2017, during the 34<sup>th</sup> Session of the Human Rights Council (HRC) (27 February – 24 March) the Foundation, together with the Permanent Mission of the Holy See, Caritas Internationalis and the International Catholic Migration Commission (ICMC) organized a side-event “Unaccompanied Children on the Move: Preserving their Dignity and Rights” which was also co-sponsored by the Forum of Catholic Inspired NGOs. Moreover, this initiative was supported by different States and institutions, including African Union and European Union.

Father Fabio Baggio, Co-Secretary of the Section on Refugees and Migrants, of the Vatican’s Dicastery for the Promotion of Integral Human Development intervened addressing the migration crisis as a global phenomenon that needs attention. The commitment of His Holiness Pope Francis on this specific issue and the necessity to be sensitive to the sufferance of unaccompanied child migrants, who are the most vulnerable, was highlighted.

H.E. Ambassador W.L. Swing, General Director of the International Organization for Migration, underscored the innocence of the minors, subjected to grave violations of fundamental rights. The interventions can be found on the homepage of the Foundation ([www.fciv.org](http://www.fciv.org)).

During the 34<sup>th</sup> Session of the Human Rights Council of the UN, the Permanent Mission of the Holy See with the support of expertise provided by the Foundation, intervened on the following topics:

## Publications

We are currently working on two new working papers:

- Analyzing the ethical impact and perspective of Lethal Autonomous Weapon Systems (LAWS): humanized robots and humans robotized? The aim is to discover the implications and impacts of LAWS, giving an ethical perspective on such a delicate issue. The work will be informally presented to the experts and discussed in the summer of 2017, thereafter published;
- The right to Water and Sanitation as a basic human right: The working paper will be a source of inspiration for the side event on the same subject, organized by the Foundation and the Permanent Mission of the Holy See during the 36<sup>th</sup> HRC session.
